## VOTING INFORMATION

---

**ELIGIBILITY** - You are eligible to vote if you are a citizen of the United States, at least 18 years old by election day, and a legal resident of Washington State. *If you have been convicted of a felony, you must have your rights restored before you register to vote. In the State of Washington, you do not have to register by political party.* You must be registered at least 30 days before an election. If you register between 15 and 30 days before an election, you must register at the Auditor's Office. Registration is permanent unless you change your address or change your name. *If you move or change your name, you may use the Mail-in Voter Registration Form to update your existing voter registration.*

**HOW TO REGISTER** - Register or pick up a Mail-in Voter registration form at the AUDITOR's OFFICE in the County Courthouse, the Bellingham City Clerk's office, Bellingham fire stations, city halls in the county, all public libraries, most schools, most grocery stores, U.S. Post Offices, the Department of Motor Vehicles when applying for or renewing your driver's license. Voter Registration forms are also available online at [www.co.whatcom.wa.us/auditor/election\\_division/registration/index.jsp](http://www.co.whatcom.wa.us/auditor/election_division/registration/index.jsp).

**VOTE BY MAIL** - Whatcom County is a vote-by-mail county. Each voter is assigned to a precinct. Your registration card will note your precinct name or number. Ballots will be sent out to all registered voters who may return their ballots by mail or deposit them at specified locations. Drop off sites for depositing ballots will be listed in the newspapers before election as well as sites where voters with disabilities may vote unassisted. It is important to notify the Auditor's Office of any change of address in order that ballots are sent to the correct address.

### WHEN TO VOTE

- PRIMARY ELECTION—February 19, 2008
- GENERAL ELECTIONS (final) on the Tuesday after the first Monday in November.
- Federal, state and county officials are chosen in EVEN YEARS; city, county and district officials in ODD YEARS.
- State ballot issues are submitted to voters at the GENERAL ELECTION.
- Local school or municipal proposals may be submitted at specified times.
